Assignor agrees that it will, upon request and at the sole expense of Assignee, sign all lawful papers, make all rightful oaths, and generally do all other and further

lawful acts, reasonably deemed necessary or expedient by Assignee or by counsel for Assignee, to assist or enable Assignee to obtain the rights and interests herein assigned.

This assignment shall be binding upon Assignor's successors and assigns, and shall inure to the benefit of the successors and/or assigns of Assignee.

Assignor agrees to waive all rights and privileges to attack the validity of any of the Marks and any registrations granted therefore which Assignor has assigned, as against anyone claiming a right under any of the aforementioned rights under Assignor's assignment.

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument.


