**RELEASE OF SECURITY AGREEMENT IN
TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is granted and conveyed as of March 31, 2010, by WELLS FARGO BANK, N.A., successor-by-merger to WACHOVIA BANK, NATIONAL ASSOCIATION (including any successor, participant, assignee or transferee thereof), a national banking association, as Administrative Agent (the "Agent"), in favor of MP TOTALCARE, INC. (including any successor in interest or permitted assignee thereof, "Grantor"), a Florida corporation, who are parties to that certain First Lien Guarantee and Collateral Agreement and that certain Trademark Security Agreement, both dated as of September 30, 2005 (together with any amendments, the "Security Agreement").

WITNESSETH

WHEREAS, Grantor has granted a security interest in certain Trademarks (as defined in the First Lien Guarantee and Collateral Agreement) pursuant to the Security Agreement, for the benefit of the Agent (the "Grant of Security Interest");

WHEREAS, the Grant of Security Interest was recorded on behalf of the Agent in the United States Patent and Trademark Office ("PTO") on October 14, 2005 at Reel/Frame No. 3175/0597, to evidence the security interest in the Trademarks;

WHEREAS, Grantor has requested that the Agent: (a) terminate and release the liens and interests of the Agent in the Trademarks; and (b) execute and deliver evidence of such termination and release for filing in the PTO;

WHEREAS, the Agent has agreed to such release and termination in connection with the implementation of the Modified Second Joint Chapter 11 Plan of Reorganization for CCS Medical, Inc. and its Affiliated Debtors, as confirmed by the United States Bankruptcy Court for the District of Delaware on or about March 11, 2010.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby acknowledges and agrees as follows:

1. Acknowledgment of Termination of Grant of Security Interest in Trademarks. All rights and security interest in the Trademarks, including but not limited to each of the trademarks set forth in Schedule I, attached hereto and incorporated herein by reference, which were granted under the Grant of Security Interest recorded at the PTO on October 14, 2005 at Reel/Frame No. 3175/0597, are hereby terminated and released and are no longer in force.
