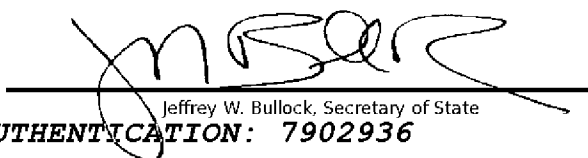

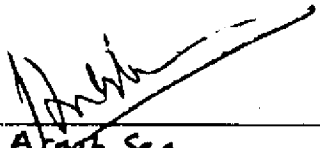
**SEVENTH:** The Certificate of Incorporation of the surviving corporation shall be the Certificate of Incorporation of Armanti Financial Services, Inc.
