Declaration of Ownership

Under 503.06(c) of the Trademark Manual of Examining Procedure (“TMEP”), The Ohio Casualty Insurance Company, a company organized and existing under the laws of Ohio and having its principal place of business at 9450 Seward Road Fairfield, Ohio 45014 (“Ohio Casualty”) hereby declares that it is and always has been the owner of the trademarks and service marks listed on Exhibit A (the “OHIO CASUALTY Marks”) and explains as follows:


A document dated December 5, 2007 purportedly assigning various trademarks and service marks, including the OHIO CASUALTY Trademarks, from Ohio Casualty to Liberty Mutual Insurance Company, a company organized and existing under the laws of Massachusetts having its principal place of business at 175 Berkeley St., Boston, MA 02116 (“Liberty Mutual”), was recorded at the Assignment Branch of the United States Patent and Trademark Office at Reel/Frame 003676/0903 on December 12, 2007. A copy of the purported assignment document and Notice of Recordation is attached hereto as Exhibit B (the “Assignment.”) The Assignment was invalid and without legal consequence with respect to the OHIO CASUALTY Marks for a number of reasons, including but not limited to the following: (i) Ohio Casualty did not intend to transfer, and Liberty Mutual did not intend to own the OHIO CASUALTY Marks and (ii) Ohio Casualty did not grant authority to the signatory of the document purporting to assign the OHIO CASUALTY Marks to Liberty Mutual. Pursuant to TMEP Section 503.01(c), the recording of an assignment that is invalid with respect to the OHIO CASUALTY Marks does not effect and should not affect title to the OHIO CASUALTY Marks.


NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, Ohio Casualty and Liberty Mutual (collectively, the "Parties") hereby agree that the ownership of the OHIO CASUALTY Marks is not affected by the Assignment. Ownership of the OHIO CASUALTY Marks always resided and continues to reside in Ohio Casualty. This Declaration of Ownership shall be considered by the Parties as being effective as of December 12, 2007, the date of the Assignment. This Declaration confirms the intent of the Parties that the Assignment caused no transfer of any right, title or interest in or to or any goodwill associated with the OHIO CASUALTY Marks.

IN TESTIMONY WHEREOF, Ohio Casualty and Liberty Mutual have caused this Declaration of Ownership to be executed by their duly authorized representatives.
