ASSIGNMENT OF A TRADEMARK

2. Assignor shall execute and deliver to Assignee any and all additional documents or perform such furthers acts as necessary and as reasonably required by the Assignee to vest title to the Mark in Assignee and or to carry out the intent of this Assignment.

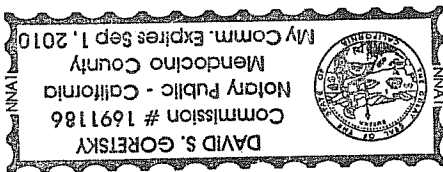
