**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Termination”) is executed and delivered as of March 31, 2010 by PNC Bank, National Association, as Administrative Agent (“Agent”), to FleetOne Holdings, LLC, TransPlatinum Service, LLC, Fleet One, L.L.C. and FleetOne Factoring, LLC (each individually, a “Borrower” and collectively, the “Borrowers”).

**BACKGROUND**

1. On November 18, 2008, the Borrowers executed and entered into an Amended and Restated Security Agreement (the “Security Agreement”) in favor of Agent, as administrative agent for the Secured Parties (as defined in the Security Agreement).

2. Pursuant to the Security Agreement, Borrowers granted to Agent for the ratable benefit of the Secured Parties a security interest in the trademarks set forth on Exhibit A attached hereto (the “Security Interest”).

3. The Security Interest was recorded in the United States Patent and Trademark Office (“USPTO”) as set forth on Exhibit A attached hereto.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

(a) Agent terminates and releases all of its right, title and interest in the trademarks set forth on Exhibit A.

(b) Borrowers, or their designee, may record this Termination in the USPTO and in any other trademark offices as may be necessary to carry out the intentions of this Termination.

(c) Agent agrees to execute and deliver such other documents as may be reasonably requested and prepared to carry out the intentions of this Termination.

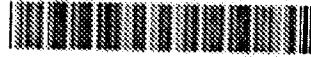
