WHEREAS, Parent, Seller and Assignee desire that Assignee acquire all of Assignors' right, title and interest in and to the Assigned IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending legally to be bound, hereby agree as follows:

1. Assignment. Parent and Seller hereby grant, bargain, sell, transfer, convey, assign, alienate, remise, release and deliver to Assignee and its successors and assigns, and Assignee does hereby accept, all of Parent's or Seller's (as the case may be) right, title and interest in, to and under, the Assigned IP, together with the right to sue and recover for all past, present and future infringements and other violations of the Assigned IP, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignors had this Assignment not been made.

2. Further Assurances. Parent and Seller covenant and agree to provide any further necessary documentation and do all further acts reasonably requested by Assignee in this regard to confirm and perfect title in and to the Assigned IP in Assignee, its successors, assigns or other legal representatives in accordance with this Assignment. In addition, Parent and Seller covenant and agree to provide to Assignee copies of (a) all available file histories of the Assigned IP and (b) maintenance documents, if any, in the Seller's or Parent's possession that relate to the maintenance documentation of any registered or issued Assigned IP, in each case including but not limited to all material correspondence with outside counsel regarding the same.

3. Successors and Assigns. This Assignment is binding on and inures to the benefit of the parties hereto, their respective successors in interest, and their respective assigns.

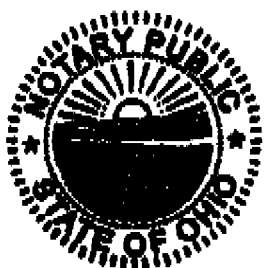
