
goodwill of the business in connection with which the Trademarks are used and which is symbolized by said Trademarks.

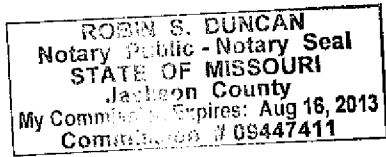



