**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of April 6, 2010, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as Agent (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Second Lien Credit Agreement, dated as of March 9, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**") among Radnet Management, Inc. (the "**Borrower**"), the other Credit Parties signatory thereto, the Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), pursuant to which the Lenders made credit extensions to the Borrower;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements listed on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower and certain of the Credit Parties granted security interests in certain trademarks owned by the Borrower and such Credit Parties including those listed on Annex I attached hereto (collectively, the "**Trademark Collateral**"); and


**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Trademark Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral to the Borrower and such Credit Parties, as applicable.
