TRADEMARK ASSIGNMENT

This Agreement is made and entered into by and between Smoky Mountain Knife Works, a Tennessee corporation with a business address at P.O. Box 4430 Sevierville, Tennessee 37864 ("Assignee"), and Ivory Enterprises, LLC, an Oregon Limited Liability Company with a business address at PO Box 23248, Tigard, Oregon 97281 and Greg Larkin, a U.S. citizen and Larkin Precision LLC, both with an address at 5810 South 194th St., Kent, Washington (hereinafter collectively referred to as "Assignors/Sellers").

WHEREAS, Assignors/Sellers used the mark Marble's in connection with knives and Assignor Ivory Enterprises is the owner of U.S. Trademark Application Serial No. 77860134 for the mark MARBLE'S, as set forth on the annexed Schedule A, (hereinafter "the Mark") for hand-operated knife to aid in skinning an animal; knife sheaths; knife sheaths of leather; and

WHEREAS, Assignee is desirous of acquiring the Mark together with the ongoing business appurtenant to the Mark and the goodwill of the business associated with and symbolized by the Mark; and

WHEREAS, Assignee has agreed to purchase certain inventory of certain goods including blades and raw materials detailed on Schedule B from Assignors/Sellers ("the Goods").

NOW, THEREFORE, in consideration of \$49,540.21 and for other good and valuable consideration, the receipt and sufficiency of which Assignors/Sellers hereby acknowledge, Assignors/Sellers do hereby assign, sell and transfer to Assignee, its successors and assigns, any and all of its right, title, and interest in and to the Mark, together with the ongoing business appurtenant thereto and the goodwill of the business symbolized by and associated therewith and ownership of the Goods.




