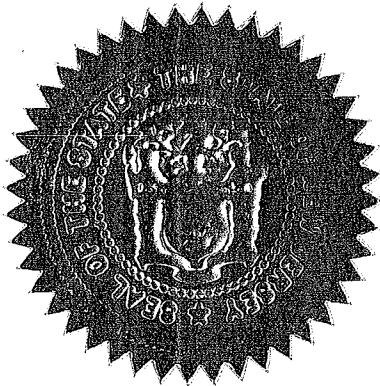

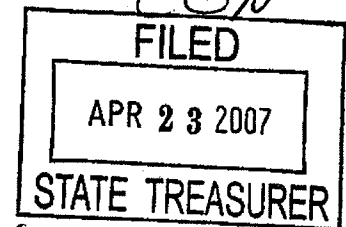

Resolved, that Article I of the Certificate of Incorporation be amended to read as follows:

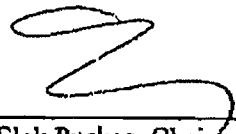
