**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**  
dated as of March ~~31~~, 2010, by HSBC CAPITAL (CANADA) INC. (the "Secured Party"), a British Columbia corporation.


**WHEREAS**, Snack Alliance, Inc., an Oregon corporation (the "Grantor"), and the Secured Party entered into a Trademark Security Agreement, dated as of July 16, 2008 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office. Issued trademarks were recorded on July 24, 2008, at Reel 003822, Frame 0242, for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Loan (as defined in the Security Agreement);

**WHEREAS**, pursuant to the Loan and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Grantor's entire right, title and interest in and to the trademark registrations and applications (as identified in the Security Agreement) including, without limitation, the trademarks listed on Exhibit A hereto (the "Intellectual Property"); and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

**NOW, THEREFORE**, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.
