## **TRADEMARK ASSIGNMENT**

ASSIGNOR hereby assigns and sells to ASSIGNEE whatever rights, title and interest Assignor may now have or has ever had in the Trademark within the United States and arising from ownership or use thereof by Assignor, and any goodwill of the business symbolized by the Trademark within the United States, together with all claims for damages by reason of infringement of the Trademark in the United States, together with the U.S. registration of the Trademark shown in Exhibit A, in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto and in and to all rights of action arising from the Trademark, all claims for damages by reason of past, present and future infringement of the Trademark and the right to sue and collect damages for such infringement, to be held and enjoyed by ASSIGNEE for its own use and benefit and for its successors and assigns as the same would have been held by ASSIGNOR had this assignment not been made, and the goodwill of the business symbolized by the Trademark.

### **2. NO REPRESENTATIONS OR WARRANTIES.**


