RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is given as of this 9th day of April, 2010, by JEFFERIES FINANCE LLC, as Collateral Agent located at 520 Madison Avenue, New York, NY 10022 (“Assignor”), in favor of PHARMANET DEVELOPMENT GROUP, INC., a Delaware corporation, located at 504 Carnegie Center, Princeton, NJ 08540 (“Assignee”).

Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement or Security Agreement, as applicable.

WHEREAS, Assignee was party to a Security Agreement, dated as of May 29, 2009 (as from time to time amended, restated, supplemented or otherwise modified, the “Security Agreement”) in favor of Assignor pursuant to which Assignee was required to execute and deliver a Trademark Security Agreement;

WHEREAS, Assignor and Assignee entered into that certain Trademark Security Agreement, dated as of May 29, 2009 (as from time to time amended, restated, supplemented or otherwise modified, the “Trademark Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 1, 2009, at Reel 3996/Frame 0736;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Assignee pledged and granted to the Assignor for the ratable benefit of the Secured Parties a lien on, and security interest in and to, all of the right, title and interest of the Assignee in, to and under the following Pledged Collateral of the Assignee (collectively, the “Trademark Collateral”):

- (a) Trademarks of the Assignee listed on Schedule 1 attached hereto; and
- (b) all Proceeds of any and all of the foregoing.

Notwithstanding anything to the contrary contained in clauses (a) and (b) above, the security interest created by the Trademark Security Agreement did not extend to, and the term “Pledged Collateral” did not include, any Excluded Property.

WHEREAS, the Assignor and Assignee desire that Assignor terminate and release its security interest in all of Assignee’s right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of the Assignee in, to and under the Trademark Collateral, including but not limited to the Trademarks listed on

Schedule 1 hereto, and reassigns and transfers any and all interest that Assignor may have in the Trademark Collateral to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its agents or designees) reasonably request (at Assignee's sole cost and expense) in order to confirm this Release and Assignee's right, title, and interest in or to the Trademark Collateral.
