**RELEASE OF GRANT OF SECURITY INTEREST
IN CERTAIN INTELLECTUAL PROPERTY**

This Release of Grant of Security Interest in Certain Intellectual Property (the "Release") is made and entered into this 7th day of April, 2010 by and between AMERICAN BLIND AND WALLPAPER FACTORY, INC., a Delaware corporation ("Company"), and ABW ACQUISITION, LLC, a Delaware limited liability company ("Lender").

WITNESSETH:

WHEREAS, Company and Lender have entered into (i) a that certain Loan and Security Agreement dated as of August 15, 2005 (as amended, the "Loan Agreement") and (ii) a that certain Supplement No. 1 dated as of April 8, 2008 (the "IP Supplement");

WHEREAS, Lender holds a security interest in specific intellectual property owned by Company as listed in Schedules I and II annexed to the IP Supplement (the "Intellectual Property") (copies of Schedules I and II are annexed hereto); and

WHEREAS, in connection with its acceptance of certain assets, including the Intellectual Property, in full satisfaction of amounts owed by the Company to the Lender under the Loan Agreement, Lender has decided to release its security interest in the Intellectual Property.

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, the parties to this Release agree as follows:

1. Lender hereby releases in its entirety its security interest in all of Company's right, title, and interest in, to, and under the Intellectual Property.
2. The parties hereto authorize and request the United States Copyright Office, and any equivalent Office in the United States or any foreign country, to record this Release against the Intellectual Property.

3. This Release shall be governed by and construed in accordance with the laws of the State of New York.

4. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.


