TERMINATION OF SECURITY INTEREST

This Termination of Security Interest, dated as of April 1, 2010, by NetQuote Inc, a Colorado corporation (the "Secured Party"), acknowledges the release and termination of its security interest in trademarks of MostChoice.com, Inc., a Georgia Corporation (the "Debtor"), as follows:

WHEREAS, the Secured Party and the Debtor are parties to that certain Trademark Security Agreement dated as of June 10, 2009, as amended, restated or otherwise modified (the "Security Agreement"; all capitalized terms not defined herein are defined in the Security Agreement), which Security Agreement was recorded with the United States Patent and Trademark Office on July 22, 2009 at reel/frame 4029/0153;


WHEREAS, pursuant to the Security Agreement, the Debtor granted the Secured Party a security interest in, and lien upon, all right, title and interest of Debtor in and to certain assets, including the Trademarks (as defined below);

WHEREAS, the Debtor filed voluntary petitions for relief under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. §§ 101 et seq., as amended, in the United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the "Bankruptcy Court"); and

WHEREAS, pursuant to an order of the Bankruptcy Court, the Secured Party's security interest in, and lien upon, the Trademarks has terminated.

NOW, THEREFORE, the Secured Party hereby acknowledges and agrees to the release and termination of its security interest in, and lien upon, the trademarks identified in Exhibit A hereto, together with the goodwill of the business associated therewith (collectively, the "Trademarks").

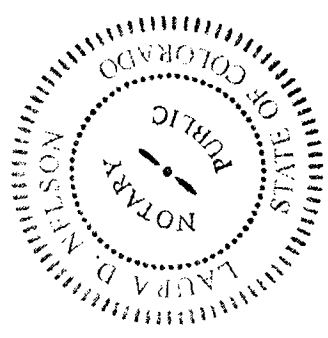
