RELEASE OF TRADEMARK SECURITY INTEREST, dated as of April 9, 2010 (this "**Release**"), by CREDIT SUISSE AG (formerly known as Credit Suisse), as Collateral Agent (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

A. Reference is made to (i) the Second Lien Credit Agreement dated as of July 31, 2007 (as amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among ITC^DeltaCom, Inc. ("**Holdings**"), Interstate FiberNet, Inc. (the "**Borrower**"), the lenders from time to time party thereto (the "**Lenders**") and Credit Suisse AG, as administrative agent and as collateral agent (in such capacity, the "**Collateral Agent**"), (ii) the Second Lien Guarantee and Collateral Agreement dated as of July 31, 2007 (as amended, supplemented or otherwise modified from time to time, the "**Guarantee and Collateral Agreement**"), among Holdings, the Borrower, the subsidiaries of Holdings party thereto, including Business Telecom, Inc. ("**BTI**") and DeltaCom, Inc. ("**DTI**" and, together with Holdings and BTI, the "**Grantors**"), and the Collateral Agent and (iii) the Second Lien Trademark Security Agreement dated July 31, 2007 (the "**Trademark Security Agreement**"), among the Grantors and the Collateral Agent (such documents set forth in clauses (i) through (iii), the "**Security Agreements**").

B. Pursuant to the Security Agreements, among other things, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the trademarks of the Grantors set forth on Schedule I hereto (the "**Trademarks**"), which security interest was recorded with the United States Patent & Trademark Office on August 31, 2007 at Reel/Frame 3612/792.

C. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all of the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks shall hereby automatically terminate as provided in the Security Agreements, and the Collateral Agent hereby terminates, releases and discharges its security interests in the Trademarks.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
