## INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of February 26, 2010 by and among SUNSHINE MEDIA GROUP, INC., a Delaware corporation ("*Holdings*"), SUNSHINE MEDIA I, INC., a Delaware corporation ("*Media*"), SUNSHINE MEDIA PRINTING, INC., a Delaware corporation ("*Printing*"), SUNSHINE MEDIA ADVERTISING, INC., a Delaware corporation ("*Advertising*"), SUNSHINE CUSTOM PUBLISHING, INC., a Delaware corporation ("*Publishing*"), SMTN, INC., a Delaware corporation ("*SMTN*"), and TRUE NORTH CUSTOM PUBLISHING, LLC, a Tennessee limited liability company ("*TNCP*"; each of Holdings, Media, Printing, Advertising, Publishing, SMTN, and TNCP, a "*Seller*" and collectively, the "*Sellers*"), and GLADSTONE CAPITAL CORPORATION, a Maryland corporation (the "*Buyer*").

### RECITALS

A. The Buyer has agreed to purchase a certain note (the "*Investment*") from the Sellers pursuant to that certain Securities Purchase Agreement by and among the Buyer and the Sellers, dated of even date herewith (as the same may be amended, modified or supplemented from time to time the "*Securities Purchase Agreement*"). Capitalized terms used herein are used as defined in the Securities Purchase Agreement.

B. The Buyer is willing to purchase such note from the Sellers, but only upon the condition, among others, that the Sellers shall grant to the Buyer security interests in the Sellers' Intellectual Property to secure the Obligations.

C. Pursuant to the terms of the Security Agreement entered into by the Sellers on the date hereof (the "*Security Agreement*"), the Sellers have granted to the Buyer first priority security interests in all of the Sellers' right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral, including without limitation, their respective Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of the Obligations, each Seller hereby represents, warrants, covenants and agrees as follows:

### AGREEMENT


To secure the Obligations, each Seller hereby grants and pledges to the Buyer a security interest in all of such Seller's right, title and interest in, to and under its Intellectual Property (including without limitation those copyrights, patents and trademarks listed under such Seller's name on Exhibits A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.
