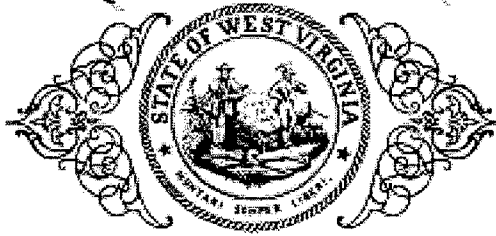

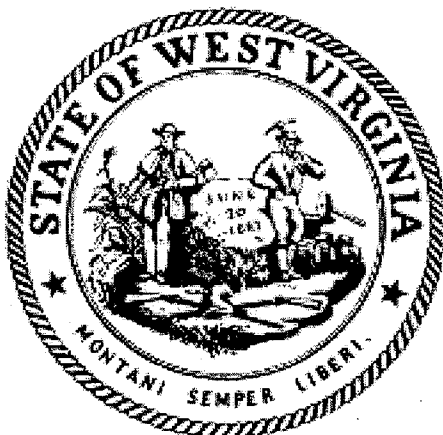

**ARTICLES OF MERGER  
OF  
LaBARGE PIPE & STEEL COMPANY  
INTO  
McJUNKIN RED MAN CORPORATION**

Pursuant to the provisions of Sections 1105 and 1106, Article 11, Chapter 31D of the Code of West Virginia, as amended (the "West Virginia Code"), and Chapter 351 of The General and Business Corporation Law of Missouri, the undersigned corporations adopt the following Articles of Merger for the purpose of merging LaBarge Pipe & Steel Company, a Missouri corporation, with and into McJunkin Red Man Corporation, a West Virginia corporation, by which merger McJunkin Red Man Corporation will be the surviving corporation (the "Merger").

FIRST: The name of the surviving corporation is McJunkin Red Man Corporation, a West Virginia corporation ("McJunkin Red Man"), and the name of the corporation being merged into this surviving corporation is LaBarge Pipe & Steel Company, a Missouri corporation ("LaBarge").

SECOND: McJunkin Red Man owns one hundred percent (100%) of the outstanding shares of LaBarge.

THIRD: The Agreement and Plan of Merger (the "Plan of Merger") was duly approved by the Board of Directors and sole shareholder of McJunkin Red Man, in the manner prescribed by Chapter 351 of The General and Business Corporation Law of Missouri and by Section 1104, Article 11, Chapter 31D of the West Virginia Code.

FOURTH: The Plan of Merger and the performance of its terms were duly authorized by all action required under Chapter 351 of The General and Business Corporation Law of Missouri and by the Articles of Incorporation of LaBarge.

FIFTH: The name of the surviving corporation is McJunkin Red Man Corporation.

SIXTH: The Articles of Incorporation of the surviving corporation shall be its Articles of Incorporation.

SEVENTH: The merger is to be effective as of 11:59 p.m. (Eastern Time) on January 21, 2010.
