The Assignor hereby assigns and transfers to the Assignee, who accepts such assignment, without warranty as to the validity thereof, for good and valuable consideration, the receipt of which is hereby acknowledged, the entire rights, title and interest in and to the Trade-marks, and the goodwill of the business attached therewith.

The Assignor further assigns to the Assignee the right to sue for past infringement and to recover and retain all damages and profits arising therefrom.

Assignor warrants that, upon the request of the Assignee, it shall execute all papers, make all rightful oaths, testify on behalf of Assignee, and do all other acts necessary to carry out the intent of this agreement, as well as to provide such other material, information and/or assistance as Assignee may consider necessary


The assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction and all those in privity therewith.


