**NUNC PRO TUNC ASSIGNMENT  
OF TRADEMARKS**

WHEREAS, JOBIS Bekleidungsindustrie GmbH & Co. KG, a German corporation, having an address of Am Stadtholz 39, D-33609 Bielefeld, (hereinafter referred to as "ASSIGNOR"), was the exclusive and record owner of the entire unencumbered right, title and interest in and to: (1) the trademarks and the corresponding United States Trademark Registrations therefore (the "Trademarks") shown on the attached **Schedule A**; and

WHEREAS, The TJX Companies, Inc., a Delaware corporation, having a principal place of business at 770 Cochituate Road, Framingham, Massachusetts 01701 (hereinafter referred to as "ASSIGNEE"), has acquired and purchased from Assignor the Trademarks, and associated good will from ASSIGNOR, effective December 1, 2009, and is desirous of confirming that it has done so; and

WHEREAS, Mr. Jochen Schnake, having offices at Ravensberger Straße 37, 33824 Werther, Germany is acting as involency administrator on behalf of ASSIGNOR and has authority to execute this Assignment on behalf of ASSIGNOR; and

WHEREAS, ASSIGNOR and ASSIGNEE desire to confirm and perfect the sale and assignment of said Trademarks effective December 1, 2009.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms that effective December 1, 2009, ASSIGNOR sold, transferred, and assigned to said ASSIGNEE the entire right, title, and interest in and to the Trademarks, together with the goodwill of the business appurtenant to and symbolized by said Trademarks, and all rights of action against third parties for past infringement thereof, the same to be held and enjoyed by said ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had the sale, transfer, and assignment not been made.

ASSIGNOR hereby warrants and covenants that it had the full power and authority to convey the rights, title, and interests sold, transferred, and assigned to ASSIGNEE, that it has not executed and will not execute any agreement in conflict herewith, and that it will execute any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed.

IN WITNESS WHEREOF, ASSIGNOR, intending to be legally bound, has caused this NUNC PRO TUNC ASSIGNMENT to be executed as of the 30th day of March, 2010.
