**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 16, 2010, is made by RBS Business Capital, a division of RBS Asset Finance, Inc., a New York corporation, having a principal office address of 53 State Street, 9<sup>th</sup> Floor, Boston, MA 02109 ("Secured Party") in favor of Alsip Acquisition, LLC, a Delaware limited liability company, having a principal office address of c/o Watermill Management Company, LLC, One Cranberry Hill, Suite 401, Lexington, MA 02421 (the "Borrower").

WITNESSETH:

WHEREAS, Secured Party was involved in a credit facility pursuant to which credit was extended to the Borrower, and in return the Borrower granted security interests pursuant to the following:

Intellectual Property Security Agreement and License dated November 6, 2009 (the "Security Agreement"), by Alsip Acquisition, LLC in favor of Secured Party, as recorded with the United States Patent and Trademark Office on November 18, 2009, Reel/Frame 004098/0412.

WHEREAS, Secured Party acknowledges full payment, performance and satisfaction of all obligations secured by the Security Agreement; and

WHEREAS, the Borrower has requested that Secured Party release its security interest in the collateral described in the Security Agreement (the "Collateral").

NOW, THEREFORE, Secured Party hereby **RELEASES** all of its security interest in the Collateral, namely, the trademarks listed in Schedule A, such schedule attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreement.

Secured Party agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of Secured Party's security interest in the Collateral.
