Grant of Security Interest in Trademarks

GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Grant"), dated as of April 16, 2010, made by American Residential Services L.L.C. ("Grantor"), in favor of U.S. Bank National Association ("Secured Party").

WHEREAS, the Grantor is the owner of the trademarks and service marks set forth on Schedule 1 attached hereto, including the associated registrations and applications for registration set forth in Schedule 1 attached hereto (collectively, the "Trademarks"); and

WHEREAS, pursuant to the Second Lien Security Agreement dated as of April 16, 2010, by and between Grantor, the other grantors party thereto and the Secured Party (the "Security Agreement"), Grantor granted to Secured Party, for the ratable benefit of the Secured Parties (as such term is defined in the Security Agreement) a security interest in, and lien on, certain intellectual property owned by the Grantor, including the Trademarks and the goodwill of the business symbolized by the Trademarks and all products and proceeds of the foregoing (collectively, the "Trademark Collateral"); and

WHEREAS, pursuant to the Security Agreement, Grantor agreed to execute and deliver to Secured Party this Grant for purposes of filing the same with the United States Patent and Trademark Office (the "PTO") to confirm and evidence the security interest in the Trademark Collateral granted pursuant to the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions of the Security Agreement, the Grantor hereby grants to Secured Party a security interest in, and lien, on the Trademark Collateral; *provided* that no security interest shall be granted in the United States on intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law.

The Grantor hereby acknowledges the sufficiency and completeness of this Grant to create the security interest in the Trademark Collateral and to grant the same to the Secured Party, and the Grantor hereby requests the PTO to file and record the same together with the annexed Schedule 1.

The Grantor and the Secured Party hereby acknowledge and agree that the security interest in the Trademark Collateral may be terminated only in accordance with the terms of the Security Agreement.

Notwithstanding anything herein to the contrary, the lien and security interest granted to Secured Party pursuant to this Agreement and the exercise of any right or remedy by Secured Party hereunder are subject to the provisions of the Intercreditor Agreement, dated as of April 16, 2010 (as amended, modified, supplemented or replaced from time to time, the "Intercreditor Agreement"), among GMAC Commercial Finance LLC,

as First Lien Agent, and U.S. Bank National Association, as Second Lien Agent and any Permitted Additional Second Lien Debt Representative (as such term is defined in the Inter-creditor Agreement).
