TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This Termination and Release of Security Interest in Trademark Rights is dated April 14, 2010.

WITNESSETH:

WHEREAS, Elmhurst Dairy, Inc., a New York corporation ("Elmhurst"), Worcester Creameries Corp., a New York corporation ("Worcester"), and Dora's Naturals, Inc., a New York corporation ("Dora's" and collectively with Elmhurst and Worcester, the "Grantors"), each located at 155-25 Styler Road, Jamaica, New York 11433, and Bank of America, National Association (as successor by merger to LaSalle Business Credit, LLC), as agent ("Agent") for itself and various other lenders, were parties to a certain Trademark Security Agreement dated September 9, 2004 (the "Trademark Agreement"), pursuant to which Grantors granted to Agent, for the benefit of lenders, a security interest in all of Grantors' rights, title and interests in and to the trademarks described on Schedule I attached hereto; and

WHEREAS, such Trademark Agreement was recorded with the United States Patent and Trademark Office on September 15, 2004, at Reel/Frame No. 002943/0898; and


