TRADEMARK SECURITY AGREEMENT dated as of October 6, 2009 (this “*Agreement*”), among EGL EAGLE GLOBAL LOGISTICS, L.P., EAGLE PARTNERS, L.P., and LAW DEBENTURE TRUST COMPANY OF NEW YORK, as Collateral Agent (in such capacity, the “*Collateral Agent*”).

Reference is made to (a) the US Collateral Agreement dated as of October 6, 2009 (as amended, supplemented or otherwise modified from time to time, the “*Collateral Agreement*”), among CEVA Limited, each subsidiary of CEVA Limited from time to time party thereto, and the Collateral Agent and (b) the Indenture dated as of October 6, 2009 (as amended, supplemented or otherwise modified from time to time, the “*Indenture*”), among CEVA Group Plc, the Guarantors named therein from time to time, The Bank of New York Mellon, as Trustee, Registrar, Principal Paying Agent and Transfer Agent, the Collateral Agent and The Bank of New York Mellon (Ireland) Limited, as Irish Paying Agent and Transfer Agent. The undersigned subsidiaries of CEVA Limited are executing and delivering this Agreement pursuant to the terms of the Indenture to induce potential investors to purchase the Securities. The undersigned subsidiaries of CEVA Limited are affiliates of the Company, will derive substantial benefits from the sale of the Securities and are willing to execute and deliver this Agreement in order to induce potential investors to purchase the Securities. Accordingly, the parties hereto agree as follows:

Section 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement. The rules of construction specified in Section 1.03 of the Indenture also apply to this Agreement.

Section 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Guarantee, each Pledgor party hereto, pursuant to the Collateral Agreement, did and hereby does grant to the Collateral Agent, its successors and assigns, for the benefit of the Senior Second Priority Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Pledgor or in which such Pledgor now has or at any time in the future may acquire any right, title or interest (collectively, the “*Trademark Collateral*”):

(a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I (the “*Trademarks*”);

(b) all goodwill associated with or symbolized by the Trademarks; and

(c) all assets, rights and interests that uniquely reflect or embody the Trademarks.

Section 3. Collateral Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. Each Pledgor party hereto hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.


