ASSIGNOR warrants and represents that it owns the unencumbered and complete right, title, and interest to the MARKS, possesses the unencumbered right and authority to grant this Assignment, that there are no prior licenses or assignments concerning the MARKS, that the MARKS do not infringe the rights of any third party, that no claims, demands, or lawsuits have been asserted concerning the MARKS, that the MARKS have not been and are not currently being infringed by any third party, and that ASSIGNOR does not own or use, has not applied for, and will not use or apply for any trademarks, service marks, or trade dress identical to or similar to the MARKS.
