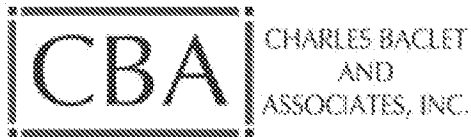

1. That the name of the corporation is 3GENLABS, INC. The date of filing the original Certificate of Incorporation of the corporation with the Secretary of State of the State of Delaware is September 15, 2008. The original Certificate of Incorporation was subsequently amended and restated on May 1, 2009 and October 26, 2009.
