WHEREAS MAPEI Inc., a legal entity organized and existing under the laws of Canada, with an address at 2900 Avenue Francis-Hughes, Laval, Quebec H7L 3J5 is the owner of a number of trademark registrations ("The Marks") in the United States as evidenced in Schedule A attached hereto; and

AND WHEREAS the use of these marks by MAPEI Inc. is under the control and ownership of the company MAPEI S.p.A., a legal entity organized and existing under the laws of Italy with an address at Via Cafiero 22, 20158 Milan, Italy, which establishes quality standards for all goods sold under The Marks by MAPEI Inc. in the United States, and

WHEREAS the parties wish to simplify administration and maintenance with regard to United States trademark registrations,

WHEREAS, MAPEI Inc. desires to transfer and assign all right, title and interest in and to The Marks together with the goodwill of the business

associated with The Marks, and MAPEI S.p.A. is desirous of accepting such registrations and assuming ownership and control of the registrations which correspond to use of The Marks in the United States, and to accept the goodwill, and to henceforth manage such marks as applied to goods sold in commerce in United States.

NOW THEREFORE, for the sum of One Dollar (\$1.00) and other good and valuable consideration, the sufficiency of which is hereby conclusively acknowledged, MAPEI Inc. transfers and assigns all of its right, title and interest in and to The Marks and the trademark registrations listed in Schedule A, attached hereto, to MAPEI S.p.A., including the goodwill attendant to such marks and registrations.
