TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 8, 2007, by MERRILL LYNCH CAPITAL, a division of Merrill Lynch Business Financial Services Inc., in its capacity as Agent (in such capacity, "Grantee").

WITNESSETH:

WHEREAS, Grantee and Transit Care, Inc., a California corporation ("Grantor") are parties to that certain Trademark Security Agreement dated as of October 28, 2005 (the "Assignment"; Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Assignment), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on November 14, 2005, at Reel 3193, Frame 0946; and

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

a. each Trademark listed on Schedule 1 annexed hereto, together with any renewals thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


b. all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to the goodwill associated with any Trademark.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
