NOW, THEREFORE, in consideration of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assign and transfer to Assignee, Assignor's entire right, title and interest in and to (i) the Marks and said registrations therefor, (ii) the goodwill of the business symbolized by the Marks, (iii) all income, royalties, damages and payment now or hereafter due or payable in respect to the Marks and (iv) all causes of action (either in law or equity) and the right to sue, counterclaim and recover for past, present and future infringement, dilution or

misappropriation of the rights assigned to Assignee hereunder. Upon the reasonable request of Assignee, Assignor shall reasonably cooperate with Assignee in executing appropriate assignment documents provided by such Assignee as may be required for completing the formalities to secure Assignee the rights hereby transferred. Assignor shall transfer physical possession of the files regarding the Marks that are in their possession upon said transfer.

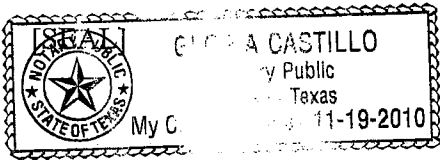
