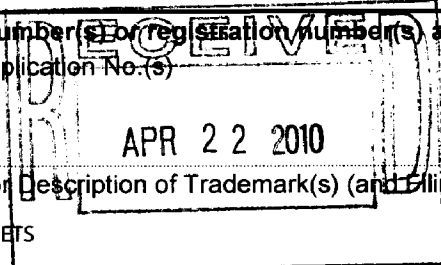

TRADEMARK AND PATENT SECURITY AGREEMENT

THIS TRADEMARK AND PATENT SECURITY AGREEMENT (the "Agreement") made as of this April 9, 2010 by WEATHER SHIELD MFG., INC., a Wisconsin corporation, THE PEACHTREE COMPANIES, INC., a Wisconsin corporation, WEATHER SHIELD, INC., a Wisconsin corporation, SCHIELD BROS., INC., a Wisconsin corporation, WEATHER SHIELD TRANSPORTATION, LTD., a Wisconsin corporation, WEATHER SHIELD EXPORT, INC., a Nevada corporation, PEACHTREE DOORS AND WINDOWS INC., a Tennessee corporation, SNE SPECIAL SERVICES, INC., a Delaware corporation, SNE TRANSPORTATION COMPANY, INC., a Wisconsin corporation and SNE ENTERPRISES, INC., a Delaware corporation (each, a "Grantor," and together, the "Grantors"), in favor of RIDGESTONE BANK, a Wisconsin banking corporation ("Lender").

WITNESSETH

WHEREAS, certain Grantors have entered into that certain Loan Agreement as borrowers (collectively, the "Borrowers"), and Lender dated as of the date hereof (as same may be amended, restated, supplemented or modified from time to time, the "Loan Agreement") providing for the extensions of credit to be made to Borrowers by Lender;

WHEREAS, Grantors have entered into guaranty agreements and security agreements as guarantors in favor Lender, dated as of the date hereof (as same may be amended, restated, supplemented, or modified from time to time, collectively, the "Guaranty Documents") providing for the guaranty of certain obligations;

WHEREAS, each Grantor has granted to Lender a security interest in certain of the assets of such Grantor including all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired trademarks and patents, together with the goodwill of the business symbolized by such Grantor's trademarks and patents and all products and proceeds thereof, to secure the payment of all amounts owing by Borrowers and guarantors under the Loan Agreement or the Guaranty Documents, as applicable;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. Incorporation of Loan Agreement and Guaranty Documents. The Loan Agreement or the Guaranty Documents, as applicable, and the terms and provisions thereof are hereby incorporated in their entirety by this reference. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to them in the Loan Agreement or the Guaranty Documents, as applicable.

2. Grant and Reaffirmation of Grant of Security Interests To secure the payment and performance of the Obligations under the Loan Agreement and the Liabilities under the Guaranty Documents, as applicable, each Grantor hereby grants Lender, and hereby reaffirms its grant pursuant to the Loan Agreement of a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created, acquired or arising:

(i) each trademark, trademark application, patent and patent application listed on Schedule 1 annexed hereto (such trademarks and trademark applications, the "Trademarks" and such patents and patent applications, the "Patents"), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the forgoing, including without limitation, any claim by such Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or Patent, or (b) injury to the goodwill associated with any Trademark.

3. Covenants. Each Grantor agrees not to sell, license, grant any option, assign or further encumber its rights and interest in the Trademarks or Patents (other than Permitted Encumbrances) without prior written consent of Lender; provided that a Grantor may sell or discontinue use of any Trademark or Patent without prior written consent of Lender if such Grantor determines that such Trademark or Patent is of negligible economic value to such Grantor.

4. Representations and Warranties. Each Grantor hereby represents and warrants that the Trademarks and Patents listed on Schedule 1 attached hereto constitute all trademarks, trademark applications, patents and patent applications owned or registered to such Grantor as of the date of this Agreement.

5. Termination. This Agreement shall continue in effect until all of the Obligations and Liabilities are indefeasibly paid and satisfied in full and the Loan Agreement is terminated.
