**NOW, THEREFORE**, in view of the premises herein and with consideration, the sufficiency and receipt thereof hereby acknowledged by the parties, Assignor does hereby sell, convey, transfer and assign and deliver to Assignee, its successors and assigns, the entire right, title and interest of Wood in and to the Trademarks, together with the goodwill associated therewith and symbolized thereby, and in and to any and all renewals thereof, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignee.
