



ASSIGNOR further covenants that ASSIGNEE will, upon request of ASSIGNEE, be provided promptly with all pertinent facts and documents relating to said TRADEMARK and will promptly execute and deliver to ASSIGNEE or its designated legal representative any and all papers, instruments, declarations or affidavits required to apply for, obtain, maintain, issue and enforce said TRADEMARK, and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.
