## ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY

[Mountain High Ski Resort]

**THIS ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY** (this "**Assignment**") is made and entered into as of the 27<sup>th</sup> day of June, 2007, by and between **MOUNTAIN HIGH RESORT ASSOCIATES, LLC**, a Delaware limited liability company ("**Assignor**"), and **CNL INCOME MOUNTAIN HIGH, LLC**, a Delaware limited liability company ("**Assignee**").

### WITNESSETH:

WHEREAS, (i) Assignor; (ii) CNL Income Partners, LP, a Delaware limited partnership and an affiliate of Assignee ("**Purchaser**"); and (iii) The Talon Group, Orlando Services Division, a division of First American Title Insurance Company, entered into that certain Asset Purchase Agreement dated as of May 14, 2007 (the "**APA**") pursuant to which, among other things, Assignor has agreed to sell, assign, transfer and convey to Purchaser the assets comprising that certain ski resort facility commonly known as the Mountain High Ski Resort and certain related facilities (hereinafter collectively referred to as the "**Subject Property**");

WHEREAS, certain of the Purchaser's rights under the APA have been assigned to Assignee by that certain Partial Assignment and Assumption of Asset Purchase Agreement between Purchaser and Assignee of even date herewith;

WHEREAS, in connection with the sale and purchase of the Subject Property, Assignor wishes to assign to Assignee any and all of Assignor's right, title and interest in and to, and Assignee wishes to assume from Assignor all of Assignor's obligations and liabilities under, the Intellectual Property (as such term is defined in the APA) relating to the Subject Property, including, without limitation, the tradenames, trademark registrations, and domain names listed on **Schedule 1** attached hereto (the "**Assigned Intellectual Property**"). Unless otherwise defined herein, all capitalized terms used in this Assignment shall have the meaning given to them in the APA.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties agree as follows:

1. Assignment. Assignor hereby assigns, transfers, and conveys to Assignee any and all of Assignor's right, title and interest, together with the goodwill of the business connected therewith and symbolized by the Assigned Intellectual Property, as well as all rights to damages or profits, due as of or after the date hereof, arising out of infringement of such Assigned Intellectual Property or injury to said goodwill, and the right to sue for and receive the same in Assignee's own name.

2. Assumption. Assignee hereby assumes all liabilities and obligations of Assignor under the Assigned Intellectual Property and agrees to perform all obligations of Assignor related the Assigned Intellectual Property which are to be performed or which become due as of or after the date hereof.

3. Further Assurances. Assignor covenants with Assignee and Assignee covenants with Assignor that each will execute and deliver any additional documents and take all reasonable actions necessary to establish the rights of the other hereunder.

4. Counterparts. This Assignment may be executed by the parties in counterparts, in which event the signature pages thereof shall be combined in order to constitute a single original document.

5. Binding Effect. This Assignment shall be binding upon and inure to the benefit of Assignor, Assignee and their respective successors and assigns.


6. Governing Law. This agreement shall be governed by, and construed and interpreted in accordance with, the laws of the State of California.
