

ASSIGNOR hereby further agrees for ASSIGNOR and ASSIGNOR'S executors and administrators to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid trademark rights to said ASSIGNEE, its successors, assigns, and legal representatives, but at its or their expense and charges;

AND, ASSIGNOR hereby further agrees to provide statements or testimony in any proceeding in which said trademark may be involved.


