National Broadcast Media Corp. (the “**Corporation**”), a corporation formed under the Texas Business Organizations Code, hereby certifies as follows:

FIRST. That the name of the Corporation is National Broadcast Media Corp. The Corporation was originally incorporated under the name Bar Network, Inc. on April 5, 2006 pursuant to the Texas Business Organizations Code.

SECOND. That the Board of Directors of the Corporation adopted resolutions approving and declaring advisable the following amendment to ARTICLE I of the Corporation’s Certificate of Formation to change the name of the Corporation from “National Broadcast Media Corp.” to “TouchTunes Media Corporation”:

The text of ARTICLE I of the Certificate of Formation of the Corporation is hereby amended in its entirety to read as follows:

“The name of the Corporation is TouchTunes Media Corporation.”

THIRD. That the foregoing amendment was duly adopted and approved in the manner required by Sections 21.053-21.054, and in accordance with Section 6.201(b), of the Texas Business Organizations Code and by the governing documents of the Corporation.

FOURTH. This document shall become effective upon its filing by the Secretary of State of the State of Texas.


