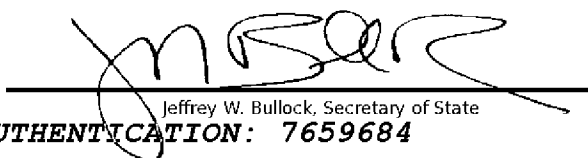

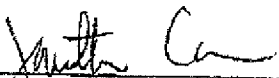
The resolution setting forth the amendment is as follows:
