INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** (the "Agreement"), effective as of February 19, 2010 (the "Effective Date"), is made by and between BUCYRUS INTERNATIONAL, INC., a corporation organized under the laws of the State of Delaware, having an office at P.O. Box 500, 1100 Milwaukee Avenue, South Milwaukee, Wisconsin 53172 ("Assignor"), and BUCYRUS MINING EQUIPMENT, INC., a corporation organized under the laws of the State of Delaware, having an office at P.O. Box 500, 1100 Milwaukee Avenue, South Milwaukee, Wisconsin 53172 ("Assignee").

WHEREAS, Assignor owns all right, title and interest in and to the registered trademarks listed in Schedule A to this Agreement ("Assigned Trademarks") and the issued patents and patent applications listed in Schedule B to this Agreement ("Assigned Patents") (collectively, the "Assigned Intellectual Property"); and

WHEREAS, Assignor desires to sell, assign, transfer and convey, and Assignee desires to accept the sale, assignment, transfer and conveyance of, the Assigned Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment of Assignor's Assigned Intellectual Property. Assignor hereby sells, assigns, transfers and conveys to Assignee, and Assignee hereby accepts the sale, assignment, transfer and conveyance from Assignor of, all right, title and interest in and to the Assigned Intellectual Property, including all goodwill associated therewith, and the rights to sue for and remedies against past, present, and future infringements of, any or all of the foregoing, and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide.

2. No Representations and Warranties. Assignor hereby disclaims all representations and warranties concerning the Assigned Intellectual Property.

3. Choice of Law. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAW.

4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same instrument.

5. Amendment: Waiver. Any provision of this Agreement may be amended or waived if, and only if, such amendment or waiver is in writing and signed, in the case of an amendment, by Assignor and Assignee, or in the case of a waiver, by the party against whom the waiver is to be effective. No failure or delay by any party in exercising any right, power or privilege hereunder shall operate as a waiver thereof nor shall any single or partial exercise

thereof preclude any other or further exercise thereof or the exercise of any other right, power or privilege. The rights and remedies herein provided shall be cumulative and not exclusive of any rights or remedies provided by law.


