RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 16, 2010 ("Effective Date") by and among **The Bank of New York Mellon**, as successor Collateral Agent (the "New Agent"), and **RE/MAX International, LLC** (formerly known as RE/MAX International, Inc.) (the "Grantor").

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of January 11, 2008 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "A&R Credit Agreement"), by and among the Grantor, RE/MAX International Holdings, Inc. ("Holdings"), the Lenders party thereto (the "Lenders"), Citigroup Global Markets, Inc., as Sole Lead Arranger, Bookrunner and Syndication Agent, and Citicorp North America, Inc., as Administrative Agent and Collateral Agent (the "Resigning Agent"), the Lenders severally agreed to make extensions of credit to the Grantors upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantor is a party to that certain Security Agreement, dated as of December 17, 2007, (as amended, supplemented, amended and restated or otherwise modified from time to time (the "Security Agreement") in favor of the Resigning Agent as the original Collateral Agent, pursuant to which Grantor executed and delivered a Trademark Security Agreement, dated as of December 17, 2007 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Resigning Agent, as the original Collateral Agent, was granted, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Collateral set forth in Section 2 of the Trademark Security Agreement, including the Trademarks identified on the attached Schedule, together with the goodwill associated with the Trademarks, and all proceeds of any and all of the foregoing (other than Excluded Property) (the "Security Interest");

WHEREAS, pursuant to the Successor Agent and Amendment Agreement, dated as of August 14, 2008, (the "Successor Agreement"), by and among the Resigning Agent, the New Agent, the Requisite Lenders (as defined in the A&R Credit Agreement), the Grantor and Holdings, the A&R Credit Agreement was amended to reflect the appointment of the New Agent as successor Administrative Agent and Collateral Agent; and

WHEREAS, in furtherance of the New Agent's replacement of the Resigning Agent as the Administrative Agent and Collateral Agent under the A&R Credit Agreement, as amended by the Successor Agreement (the "Credit Agreement"), the Trademark Security Agreement, and all other Loan Documents (as defined in the Credit Agreement), the Resigning Agent, the Successor Administrative Agent, and the Grantor executed that certain Assignment and Assumption of Security Interest in Trademarks, dated as of August 14, 2008 (the "Security Interest Assignment"), pursuant to which the New Agent acquired all of Resigning Agent's right, title and interest in, to and under the Credit Agreement, the Trademark Security Agreement, including, without limitation, the Security Interest, and all other Loan Documents relating thereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") December 26, 2007 at Reel Frame 3683/0846;

WHEREAS, the Security Interest Assignment was recorded with the PTO on August 15, 2008 at Reel/Frame: 3836/0455;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the New Agent hereby terminates, cancels and releases, without representation, warranty or recourse, express or implied, any and all security interests it has against the Specified Trademarks.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflict of laws principles thereof.
