## TRADEMARK ASSIGNMENT

ASSIGNOR has sold, assigned, and transferred and does hereby sell, assign, and transfer unto ASSIGNEE, its successors and assigns, ASSIGNOR'S entire right, title, and interest in and to the TRADEMARKS, together with the goodwill of the business in connection with which the TRADEMARKS are used, and all rights and privileges pertaining to the TRADEMARKS, including all rights of recovery for past infringement thereof and for renewal of the registrations thereof for subsequent terms, the same to be held and enjoyed by ASSIGNEE, its successors and assigns, as fully as the same would have been held and enjoyed by ASSIGNOR had this sale, assignment, and transfer not been made.

2. ASSIGNOR must, at the ASSIGNEE'S expense, provide to the ASSIGNEE such assistance as the ASSIGNEE may reasonably request in relation to prosecuting the TRADEMARKS (including defending any opposition proceedings), or maintaining or renewing the TRADEMARKS.



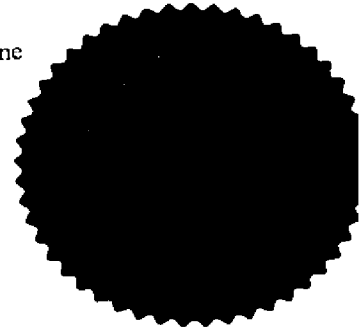


