**SHORT FORM TRADEMARK SECURITY AGREEMENT**

This SHORT FORM TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of April 27, 2010 is made by ALPINE HELICOPTERS LTD., CANADA MOUNTAIN HOLIDAYS, INC., COPPER MOUNTAIN, INC., INTRAWEST CALIFORNIA HOLDINGS, INC., INTRAWEST GOLF HOLDINGS, INC., INTRAWEST HONUA KAI HOSPITALITY MANAGEMENT, INC., INTRAWEST HOSPITALITY MANAGEMENT, INC., INTRAWEST RETAIL GROUP, INC., INTRAWEST ULC, MONT TREMBLANT RESORTS AND COMPANY, LIMITED PARTNERSHIP, RESORT RESERVATIONS NETWORK, INC., SNOWSHOE MOUNTAIN, INC., STEAMBOAT SKI & RESORT CORPORATION, AND THE STRATTON CORPORATION (collectively, the "IP Grantors"), in favor of BANK OF AMERICA, N.A., located at Bank of America Plaza, 901 Main Street, Dallas, TX 75202, as Administrative Agent (the "Administrative Agent"), for the benefit of the Secured Parties under that certain First Lien Credit Agreement, dated as of April 27, 2010 (as amended, restated supplemented or otherwise modified from time to time, the "Credit Agreement"), among INTRAWEST CAYMAN L.P., an exempted Cayman Island limited partnership ("New Cayman LP"), INTRAWEST HOLDINGS S.à r.l., a Luxembourg *société à responsabilité limitée* ("Holdings"), INTRAWEST ULC, an unlimited liability company incorporated under the laws of the Province of Alberta, Canada ("Intrawest ULC"), WINTERGAMES TRAVEL L.P., an exempted Cayman Islands limited partnership ("Travel Co."), INTRAWEST EUROPE HOLDINGS S.à r.l., a Luxembourg *société à responsabilité limitée* ("Intrawest Europe"), INTRAWEST U.S. HOLDINGS INC., a Delaware corporation ("US Holdings"), and STEAMBOAT ACQUISITION LLC, a Delaware limited liability company ("Steamboat Acquisition" and together with Intrawest ULC, Travel Co., Intrawest Europe and US Holdings, the "Borrowers"), the banks and other financial institutions from time to time parties to the Credit Agreement as Lenders (the "Lenders") and the Administrative Agent.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally made extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, the Grantors have entered into that certain First Lien Security Agreement, dated as of April 27, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Administrative Agent; and

WHEREAS, pursuant to the Security Agreement, the IP Grantors are granting to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in certain Collateral, including each of the following that are owned by the IP Grantors: (i) all trademarks, trade dress, trade names, trade styles, service marks,

logos and other source identifiers, and all goodwill associated therewith, all registrations thereof, and all applications for registration therefor, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to in Schedule A, and (ii) the right to obtain all renewals thereof (collectively, the “Trademarks”);

NOW, THEREFORE, in consideration of the premises and to induce the Lenders to make their respective extensions of credit to the Borrowers under the Credit Agreement, the IP Grantors hereby agree with the Administrative Agent, for the benefit of the Secured Parties, as follows:

SECTION 1. Definitions. Capitalized terms used but not defined herein shall have the meanings given to them in the Credit Agreement or the Security Agreement, as applicable, except the terms “Secured Parties” and “Collateral” are defined as in the Security Agreement only.

SECTION 2. Grant of Security Interest. Each IP Grantor hereby assigns and transfers to the Administrative Agent, and hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademarks now owned or at any time hereafter acquired by such IP Grantor or in which such IP Grantor now has or at any time in the future may acquire any right, title or interest (including, without limitation, those Trademarks listed on Schedule A hereto) as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such IP Grantor’s Obligations; provided, however that the Trademarks do not include any applications for Trademarks filed in the United States Patent and Trademark Office on the basis of the IP Grantor’s intent to use such mark pursuant to 15 USC 1051 Section 1(b) and for which a form evidencing use of the Trademark in interstate commerce has not been filed with the United States Patent and Trademark Office pursuant to 15 USC 1060 (a), to the extent and only for the duration that the security interest granted in such intent-to-use applications will invalidate, terminate, or abandon such intent-to-use applications under applicable law.

SECTION 3. Purpose. This Agreement has been executed and delivered by the IP Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office.

SECTION 4. Authorization to Supplement. Each IP Grantor hereby authorizes the Administrative Agent to unilaterally modify this Agreement by amending Schedule A to include any future Trademarks owned by such IP Grantor which are the subject of registrations or applications, for purposes of recording this Agreement against such newly-acquired Trademarks. Notwithstanding the foregoing, no failure to so modify this Agreement by amending Schedule A shall in any way affect, invalidate or detract from the Administrative Agent’s, or the other Secured Parties’, continuing security interest in all Trademarks owned by the IP Grantors, whether or not listed on Schedule A.

SECTION 5. Acknowledgment. Each IP Grantor does hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks are more fully set forth in the Security Agreement, the terms and conditions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.


SECTION 6. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 7. Counterparts. This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.


