TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Trademark Assignment") is by and between the University Corporation for Atmospheric Research (UCAR), a Colorado nonprofit corporation (the "Assignor"), with a mailing address of P.O. Box 3000, Boulder, Colorado 80307 and the National Earth Science Teachers Association (NESTA) a Michigan nonprofit corporation ("Assignee"), with a mailing address of P.O. Box 2194, Liverpool New York 13089-2194.

RECITALS

A. Assignor has assigned to Assignee, pursuant to the Assignment Agreement, dated as of April 12, 2010, by and between the parties (the "Agreement"), all rights, title and interests in and to the UCAR Intellectual Property (as defined in the Agreement) throughout the world, including all right, title and interest in and to the trademarks and the corresponding registrations and/or applications for registration set forth on Exhibit 1 (collectively, the "Trademarks"), together with the goodwill of the business connected with and symbolized by the Trademarks; and

B. Pursuant to the Agreement, Assignee has acquired all right, title and interest in and to the UCAR Intellectual Property, including the Trademarks, and the parties wish to confirm such acquisition.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

ASSIGNMENT

1. Assignor hereby assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to any registration of the Trademarks that issued or may issue in any jurisdiction, the right to renew and extend any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, any convention and treaty rights of all kinds, including without limitation priority right that may arise from the Trademarks, the right to sue and recover for, and the right to profits or damages due or accrued in connection with, any and all past, present, or future infringement or dilution of the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made.

2. Assignor authorizes and requests the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration of the Trademarks set forth on Exhibit 1 to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents or take any actions reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

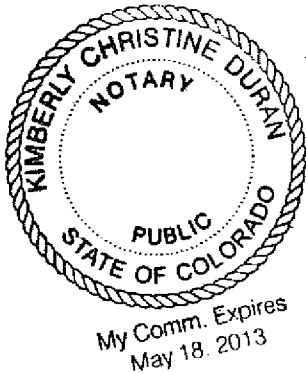

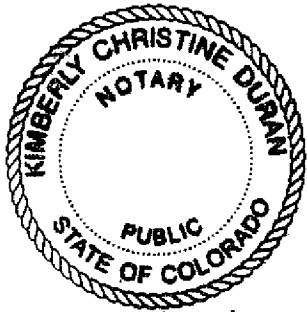
