WHEREAS, WFB wishes to terminate the Agreement and release, retransfer and reassign to Assignor, without representation or warranty, all of WFB's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, WFB hereby terminates the Agreement and releases, retransfers and reassigns to Assignor, without representation or warranty, all of WFB's right, title and interest in and to the Marks and the goodwill associated therewith.
