Alertus Technologies LLC is the rightful owner of the mark "Alertus" having first commercial use. However Intrado Inc. registered the mark despite clear first commercial use by Alertus Technologies LLC, which is easily documented in a Washington Post article on the front page of the business section of October 30, 2002, as well as other earlier media and marketing communications.

In our phone call earlier today, you mentioned that West Corporation abandoned the mark on February 24, 2009. Since the USPTO website has not updated the status, Alertus Technologies LLC would graciously appreciate a formal statement from West Corporation stating the this trademark registration by Intrado was abandoned, to resolve the issue.
