

4. On April 20 2010, the corporation adopted the following Amendment of its Articles of Incorporation:


The name of the corporation is Master Power Transmission, Inc.

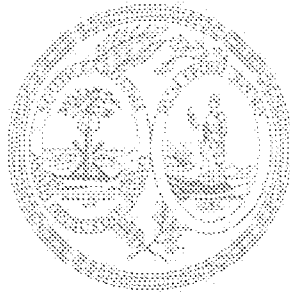
