**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, NER Data Products, Inc., a New Jersey corporation, with an address at 307 South Delsea Drive, Glassboro, New Jersey 08028 (the "Grantor") executed a Security Interest in Trademarks dated March 24, 2006, which was recorded in the U.S. Patent and Trademark Office on April 3, 2006 at Reel 3280 Frame 869 (hereinafter, the "Grant") in favor of Wells Fargo Bank, National Association, successor by merger to Wachovia Bank, National Association (hereinafter, the "Bank");



NOW, THEREFORE, in consideration of the foregoing premises, and the satisfaction of the Obligations, Bank hereby releases without representation or warranty (express or implied) Grantor and all its successors in interest from any and all interest Bank now has or which it may have with respect to the right, title and interest in and to the subject Trademarks (including, without limitation, the Trademarks set forth on Exhibit A attached hereto), the goodwill of the business symbolized by said Trademarks, and any and all license agreements relating thereto, and all other rights and interests set forth in the Grant.

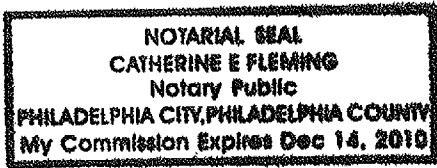
