GRANT OF SECURITY INTEREST
TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of April 30, 2010 , is executed by Fisher Detection Group, Inc., a Delaware corporation, Fisher Research Labs, Inc., a Delaware corporation, FTP Holdings I, Inc., a Delaware Corporation, FTP Holdings II, Inc., a Delaware Corporation, and JNL Trading Company, Inc., a Delaware Corporation (each a "Grantor," collectively known as the "Grantors"), in favor of Westbury Investment Partners SBIC, LP, having an address of 100 Motor Parkway, Suite 165, Hauppauge, New York 11788 ("Agent"), for the benefit of the Lenders from time to time a party to the Agreement (as hereinafter defined) (the "Lenders").

A. Pursuant to a certain Senior Secured Credit and Security Agreement, dated on or about the date hereof (the "Agreement") by and among First Texas Holdings Corporation, a Delaware corporation with an address of 1465-H Henry Brennan Drive El Paso, TX 79936, First Texas Products Corporation, a Delaware corporation with an address of 1465-H Henry Brennan Drive El Paso, TX 79936, First Texas Products LLC, a Delaware limited liability company with an address of 1465-H Henry Brennan Drive El Paso, TX 79936, and JNL Trading Company LLC, a Delaware limited liability company with an address of 1465-H Henry Brennan Drive El Paso, TX 79936 (collectively known as the "Borrowers"), Agent, and Lenders, Lenders have agreed to make a loan to Borrowers, and Borrowers have agreed to issue promissory notes (the "Notes"), upon the terms and subject to the conditions set forth therein;

B. In order to induce Agent and Lenders to enter into the Agreement and to induce Lenders to make the Loans as provided for in the Agreement, Grantors have agreed to guarantee the prompt payment, performance and observance of the Obligations (as defined in the Agreement);

C. Grantors own the registered trademarks, service marks, domain names (and applications and registrations therefor), of the United States, more particularly described on Schedule A and Schedule B annexed hereto as part hereof (collectively, the "Trademarks");

D. Pursuant to the Agreement, Grantors have granted to Agent, for the benefit of Lenders, a security interest in all right, title and interest of Grantors in and to the Trademarks, together with associated goodwill, and all proceeds therefrom, including all damages resulting from any and all causes of action which may exist by reason of infringement thereof for the full term of the Trademarks (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantors hereby further grant to Agent, for the benefit of Lenders, a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Grantors hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral granted hereby for the benefit of Lenders are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


