ASSIGNMENT OF TRADEMARKS

WHEREAS, CBS Radio Inc. ("Assignor"), a Delaware corporation formerly with a place of business at 40 West 57th Street, New York, New York 10019 (previously located at 1515 Broadway, New York, New York 10036), is the owner of the federal trademark registration No. 2,774,329 for the mark X-TREME ("Mark") on and in connection with "radio broadcasting services" in International Class 38, assigns all right, title and interest in and to the Mark, together with the goodwill and business symbolized thereby; and

WHEREAS, Infinity Radio Inc., now known as CBS Radio Stations Inc., ("Assignee"), a Delaware corporation with a place of business at 40 West 57th Street, New York, New York, New York 10019, desires to obtain all rights in and to the Mark, as at February 1, 2006.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor sells, transfers, conveys and assigns to Assignee as at February 1, 2006 all of Assignor's right, title and interest in and to the Mark, whether statutory or at common law, including all registrations and applications therefore, the right to recover for past infringement, and the goodwill of the business in connection with which it has been used.
