TERMINATION OF SECURITY AGREEMENT - TRADEMARKS

WHEREAS, Service Champ, Inc., f/k/a SCLP Acquisition Company, a Delaware corporation (the "**Borrower**"), executed and delivered in favor of Manufacturers and Traders Trust Company, a New York banking corporation (the "**Bank**"), that certain Security Agreement - Trademarks dated April 22, 2005 (the "**Security Agreement**"); and

WHEREAS, the Borrower is the owner of the trademarks and registrations therefor (the "**Trademarks**") listed on Schedule A hereto and the goodwill of the Borrower's business associated therewith; and

WHEREAS, pursuant to the Security Agreement recorded with the United States Patent and Trademark Office on April 29, 2005, at Reel/Frame 003075/0602, and corrected pursuant to a Corrective Assignment recorded with the United States Patent and Trademark Office on May 3, 2005, at Reel/Frame 003113/0713, the Borrower granted to the Bank, inter alia, a first priority security interest in and to the Trademarks, the registrations thereof, and the goodwill associated therewith; and

WHEREAS, the parties now desire to terminate the Bank's security interest in the Trademarks.


NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Bank hereby agrees as follows:

1. Effective as of the date hereof, the Security Agreement is hereby terminated, and of no further force or effect.
2. The Bank hereby releases its security interest and conveys back to the Borrower all of the Bank's interest in and to the Trademarks, the registrations thereof and the goodwill associated therewith.
3. The Bank agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Trademarks.
