NUNC PRO TUNC ASSIGNMENT

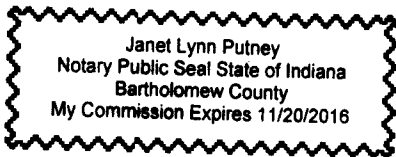
